## A. Reports

i. Executive Director's Report

Meg Rydman reported second semester is underway but it started with a hiccup. There were technical difficulties which delayed the opening of the online courses to our 6th-12th grade students. Enrollment - As of today, there are 391 students enrolled.

- 40 are elementary (TK-5),
- 67 are middle school (6-8) and
- 284 are high school (9-12).

• There are 63 sped and 30 EL, plus 1 TBD, students across the schools.

There were 19 midyear graduates, out of 20 expected.

Buellton and Lompoc are full. Orcutt is just about there - those in process and the waitlist will fill that LC up. Santa Barbara continues to struggle with enrollment. It is anticipated that enrollment will at least match the first interim enrollment estimates, but the teachers still have room for more students.

There are 62 current interested and on the waitlist.

Olive Grove is already preparing for 2024-25 enrollment. The 2024-25 intent to return survey will go out in February, in order to prepare for the lottery in late March.

**DISCUSSION:** Meg explained that State law requires that schools annually prepare and distribute a School Accountability Report Card (SARC). A similar requirement is also contained in the federal Elementary and Secondary Education Act (ESEA). The purpose of the SARC is to provide parents/guardians and the community with important information about each school. SARCs must be updated annually, reviewed and approved by the school's Governing Board, and published by February 1. The CDE provides an electronic SARC template available through an online web application with much of the required data pre-populated. It allows local education agencies (LEAs) to input the remaining information as well as review and correct some portions of the pre-populated data, if necessary.

As it applies to this agenda item, AB 1078 requires schools to update their anti-discrimination policies to clarify that the policy also applies to the charter school governing board. This updated policy replaces the Notice of Non-Discrimination previously approved and revised by the Board. **APPROVED** by a vote of 3-0
