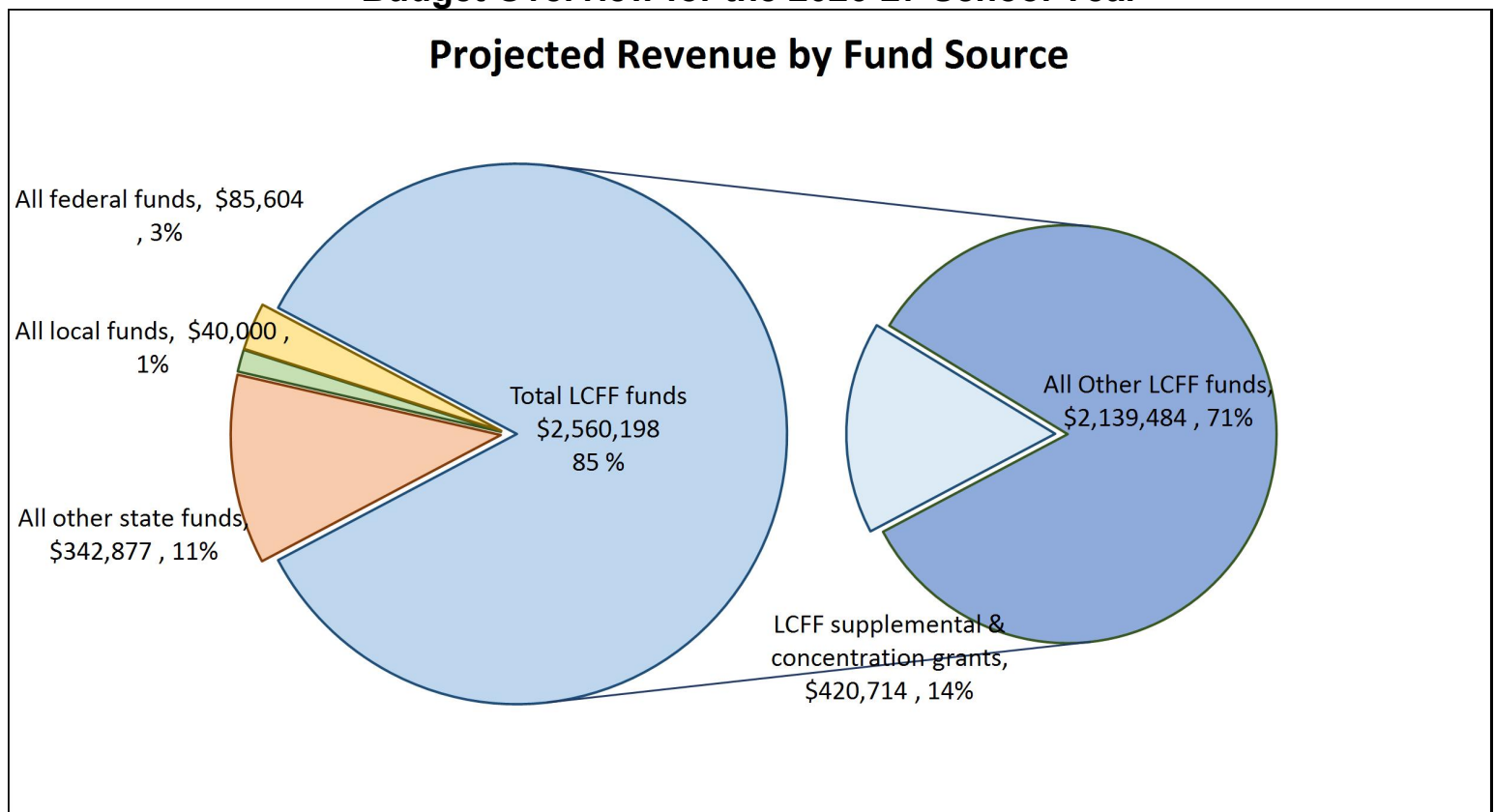

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (Foster Youth, English learners, and low-income students).

Budget Overview for the 2026-27 School Year

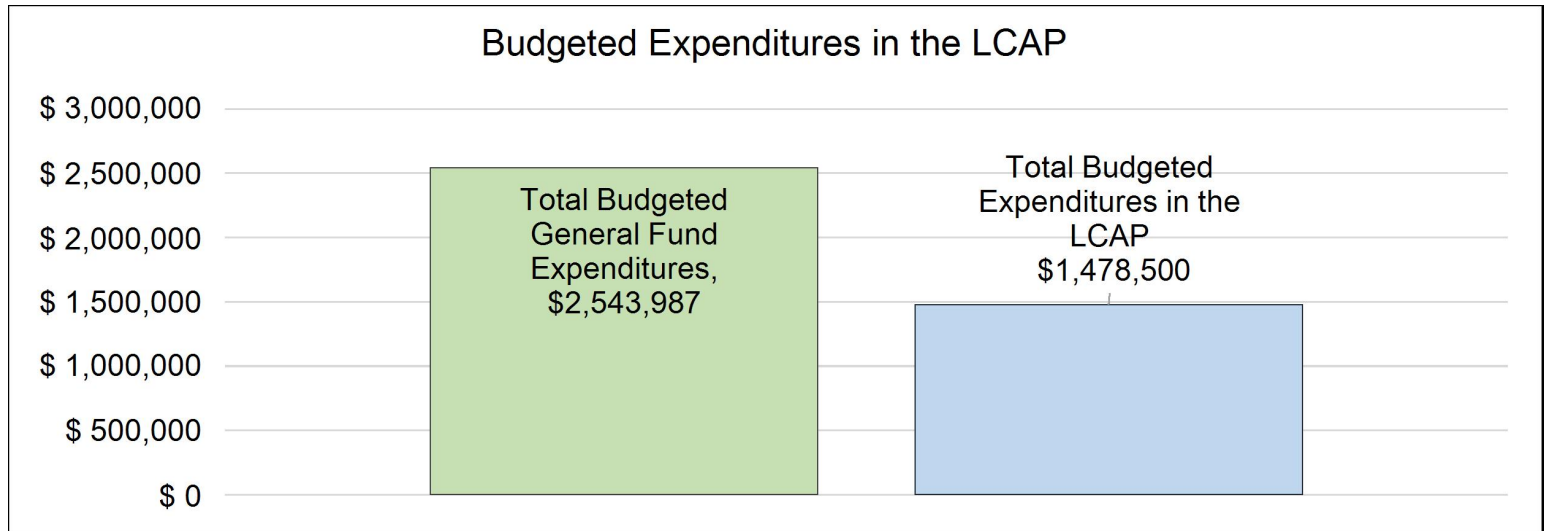


This chart shows the total general purpose revenue Olive Grove Charter - Orcutt/Santa Maria expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Olive Grove Charter - Orcutt/Santa Maria is \$3,028,679, of which \$2560198 is Local Control Funding Formula (LCFF), \$342877 is other state funds, \$40000 is local funds, and \$85604 is federal funds. Of the \$2560198 in LCFF Funds, \$420714 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



This chart provides a quick summary of how much Olive Grove Charter - Orcutt/Santa Maria plans to spend for 2026-27. It shows how much of the total is tied to planned actions and services in the LCAP.

The text description of the above chart is as follows: Olive Grove Charter - Orcutt/Santa Maria plans to spend \$2543987 for the 2026-27 school year. Of that amount, \$1478500 is tied to actions/services in the LCAP and \$1,065,487 is not included in the LCAP. 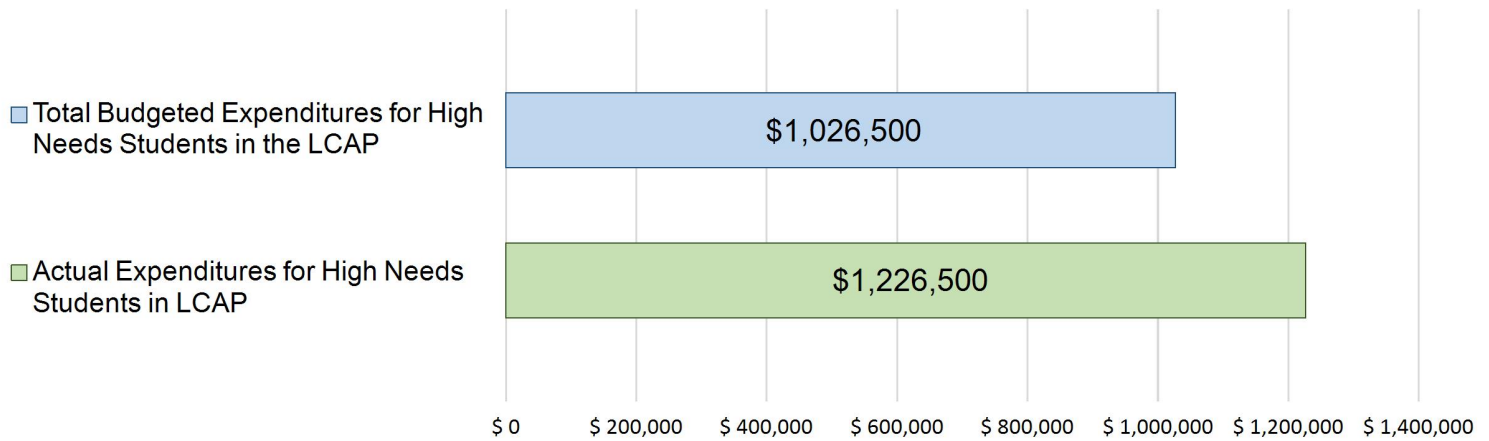
Increased or Improved Services for High Needs Students in the LCAP for the 2026-27 School Year

In 2026-27, Olive Grove Charter - Orcutt/Santa Maria is projecting it will receive \$420714 based on the enrollment of Foster Youth, English learner, and low-income students. Olive Grove Charter - Orcutt/Santa Maria must describe how it intends to increase or improve services for high needs students in the LCAP. Olive Grove Charter - Orcutt/Santa Maria plans to spend \$900000 towards meeting this requirement, as described in the LCAP.

The text description of the above chart is as follows: In 2025-26, Olive Grove Charter - Orcutt/Santa Maria's LCAP budgeted \$1,026,500 for planned actions to increase or improve services for high needs students. Olive Grove Charter - Orcutt/Santa Maria actually spent \$1,226,500 for actions to increase or improve services for high needs students in 2025-26.
